

## Changes in Technology

There are some new technologies coming to our District that may affect how you do your job — one of these is the Portal project. ETS is working with the campuses and Central Services to provide staff and faculty with their own web page, or portal, containing information and easy access to many of the services you use in your work.

More than one hundred volunteers are now testing the portal. It will be available this summer with web pages designed just for you. Once you enter the log-on information, the portal can give you access to your email, Meeting Maker calendar, direct deposit pay stubs and more, with only one password. These services will be available from anywhere on the web, even at home.

Reports designed just for Deans will allow them to track the latest enrollment figures on their portal site. Faculty will find lists on their pages showing student status in the classes they teach. Web availability allows part-time faculty access to these same services from outside the District.

Your payroll timesheet will soon be submitted electronically. Testing has already begun, and most users have found the new system easier to use than the current paper versions. These too will be made available through the portal.

To be sure all employees have the computer skills needed to take advantage of these services, the District has begun a training program. Forty users have already attended, and about fifty more will be given instruction. Those who do not have access to computers will have one provided for them to use in their work area.

The passage of Measure C will guarantee more technology improvements in the District. Look for some exciting changes in the months and years to come.
