What is the overall deductible?	\$500 per individual / \$1,000 per family for <u>Preferred Providers</u> ; \$2,000 per individual / \$4,000 per family for <u>non-preferred providers</u> .	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible?	Yes. <u>Prescription Drugs</u> , <u>Preventive</u> <u>care</u> , Primary Care visit, and <u>Specialist</u> visit for <u>Preferred Providers</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. Are there other deductibles for specific services?	No.	You don't have to meet <u>deductibles</u> for specific services.
What is the <u>out-of-pocket</u> <u>limit</u> for this <u>plan</u> ?	\$2,000 per individual / \$4,000 per family for Preferred Providers; None per individual / None per family for Non-Preferred Providers. This plan has a separate Out of Pocket Maximum for Prescription Drugs of \$2,000 per individual / \$4,000 per family / \$1,000 Home Delivery.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this <u>plan</u> , they have to meet their own <u>out-of-pocket limits</u> until the overall family <u>out-of-pocket limit</u> has been met.  However, these expenses do count toward the maximum medical responsibility amount. The maximum medical responsibility (\$7,200 per Member and \$14,400 per family), in general, is accumulated by the Calendar Year Deductible, Coinsurance, and Copayments, for services provided by Preferred Providers.
